Missouri's fuel tax rate is 17 cents a gallon for all motor fuel, including gasoline, diesel, kerosene, gasohol, ethanol blended with gasoline, etc. Missouri also collects two fees on all sales of fuel. The fees collected are the state inspection fee in the amount of 3.5 per 50 gallons (.0007) and the transport load fee in the amount of \$28.00 per 8,000 gallons(.0035 per gallon).
